EXHIBITOR CONTRACT

FULL EXHIBIT FEE INCLUDES:

- One free main conference registration (excluding Pre-Conference Institutes). Any additional
 individuals assisting with the exhibit must register as a regular conference participant at the regular
 conference rates.
- One 6' table (total space is 8') with two chairs. (Extra tables are available for purchase for an additional charge of \$175 upon request.)
- General lighting, standard heating and/or AC, and in-house linens and skirting
- Logo placement on the conference website and app linked to your website

FEE DOES NOT INCLUDE:

- Shipping, handling, drayage, electricity, audio-visual equipment.
- Assistance with moving boxes or setting up the exhibit (exhibitor must contract with the hotel for these services).

REFUND POLICY

The acceptance and confirmed assignment of space shall be subject to the regulations outlined in this contract. All requests for refunds must be made in writing (email is sufficient) and dated on or before September 23, 2022. Cancellations after September 23, 2022, will result in forfeiture of the required payment. Eligible requests will entitle the registrant to a full refund less a \$50 processing fee. In lieu of requesting a refund, an organization may send someone else in the place of the initial registrant, if the original registrant is unable to attend and if they notify Healthy Teen Network in writing by October 7, 2022.

TERMS OF AGREEMENT

Healthy Teen Network shall not, nor shall any of its associates, agents, employees, and beneficiaries (hereafter called indemnities), be liable for damage or loss to exhibitor's properties through theft, fire accident, or any destructive cause. Exhibitor shall be fully responsible to pay for any and all damages to property owned by the Hyatt Regency Miami, its owners, or managers that result from any act or omission of Exhibitor. Exhibitor agrees to defend, indemnify, and hold harmless, Hyatt Regency Miami and Healthy Teen Network, their owners, managers, officers or directors, agents employees, subsidiaries, and affiliates from any damages or charges resulting from Exhibitor's use of the property. Exhibitor's liability shall include all losses, costs, damages, or expenses arising from, out of, or by reason of any accident or bodily injury or other occurrences to any person or persons, including the Exhibitor, its agents, employees, and business invitees which arise from or out of the Exhibitor's occupancy and use of the exhibition premises, the Hotel, or any





part thereof. It shall be the responsibility of each exhibitor to maintain insurance coverage against injury to persons or damage to or loss of property or to meet its obligations under this agreement, in such amounts as the exhibitor shall deem adequate. Insurance is not provided by Healthy Teen Network.

Nothing shall be posted, nailed, screwed, or otherwise attached to columns, walls, floors, or other parts of the hotel and/or exhibit hall area. Packing, unpacking, and assembly of exhibits shall be done only in designated areas and in conformity with the directions of the Conference Manager, the hotel, or exhibit hall manager. The subletting, assignment, or apportionment of the whole or any part of the exhibitor's space, by any exhibitor, is prohibited. Healthy Teen Network reserves the right to expel, decline, or prohibit any exhibit or part of any exhibit which is not suitable or in accordance with the values/ethics of Healthy Teen Network, or which does not comply with the rules established. This reservation concerns persons, conduct, printed matter, souvenirs, catalogues, etc. Sound equipment may be used with special permission and, when used, must not interfere with other exhibitors or conference events. In case of any such declination, cancellation, or removal, it is agreed by the contracting parties that no liability shall be attached to Healthy Teen Network by reason of any such actions. Exhibitors must conform to fire department regulations.

Distribution of literature, samples, etc., by firms that are NOT participating as an exhibitor is prohibited. Evidence of violation of this rule should be reported immediately to a Healthy Teen Network representative. Unethical conduct or infraction of rules on the part of the exhibitor or their representative, or both, will subject the exhibitor or their representative to dismissal from the exhibit area, and no refund will be made by Healthy Teen Network. Exhibitors shall not schedule entertainment or social functions which conflict with conference program hours or social periods held during October 17-19, 2022.

Healthy Teen Network reserves the right to construe and apply all rules and regulations for exhibitors and, when in the judgment of Healthy Teen Network exceptions or additions are necessary, the decision of Healthy Teen Network shall be binding in all instances. Healthy Teen Network reserves the right to accept or reject any advertisement submitted for Healthy Teen Network's publications. However, Healthy Teen Network does not attempt to investigate or verify claims, including claims of compliance with Healthy Teen Network codes and standards, made in advertisements appearing in Healthy Teen Network's publications and on its websites.
